12.3 The Commission will endeavor to accommodate the candidates in the Centres opted by them. However, the Commission reserves the right to add new Centre(s) of Examination in addition to the list of Centres given at **Para 12.1** above or to cancel any Centre from the aforesaid list and ask the candidates opting that Centre to appear from any another Centre. The Commission also reserves the right to divert candidates of a Centre to some other Centre to take the examination.

- 13.1 The Computer Based Examination will be conducted in two tiers as indicated below:
 - 13.1.1 Tier-I
 - 13.1.2 Tier-II
- 13.2 Marks scored by the candidates in Computer Based Examination, if conducted in multiple shifts, will be normalized by using the procedure published by the Commission vide Notice dated 02-06-2025 and such normalized scores will be used to determine final merit and cut-off marks.
- 13.3 Tentative Answer Keys of the Computer Based Examinations will be placed on the website of the Commission after the Examination. Candidates may go through the Answer Keys and submit online representations, if any, within the stipulated time limit on payment of ₹ 100/- per question, which is non-refundable. Representations received through any other mode e.g. letter, application, email, etc. will not be entertained. Representations regarding the Tentative Answer Keys will be scrutinized before finalizing the Answer Keys and the decision of the Commission in this regard will be final. The Final Answer Keys will be used for processing the result of Computer Based Examination and the same will be uploaded on the website of the Commission after the declaration of result of Computer Based Examination.
- 13.4 The schedule of examinations indicated in the Notice is tentative. Any change in the schedule of examinations or any other information about the examination will be communicated to candidates only through the website of the Commission.
- 13.5 In the question papers, wherever necessary, the Metric systems of weights and measures will be used.
- 13.6 There shall be no provision for re-evaluation/ re-checking of the scores of any stage/ Tier(s) of the examination. No correspondence in this regard shall be entertained.

13.8.1 Tier-II will include following four sections as under:

13.8.1.1 Section-I:

- (i) A: Mathematical Abilities
- (ii) B: Reasoning and General Intelligence.
- 13.8.1.2 Section-II:
 - (i) A: English Language and Comprehension
 - (ii) B: General Awareness
- 13.8.1.3 Section-III: Computer Knowledge Test
- 13.8.1.4 Section-IV: Skill Test/Typing Test
- 13.8.2 Tier-II will be conducted in two sessions:- Session-I & Session-II, on same day. Session-I will include conducting of Section-I, Section-II and Section-III. Session-II will include conducting of Section-IV.
- 13.8.3 Session-I will include conducting of Section-I, Section-II and Section-III. Therefore, duration of Session-I will be 2 hours and 15 minutes.
- 13.8.4 Section-I has two Parts viz. A (Mathematical Abilities) and B (Reasoning and General Intelligence). The candidates will get one hour to complete this section. On completion of one hour, this section will get automatically closed.
- 13.8.5 Immediately after completion of Section-I, the two Parts of Section-II viz. A (English Language and Comprehension) and B (General Awareness), will start. Section-II will also be for one hour and immediately on completion of one hour, this section will get automatically closed.
- 13.8.6 Section-III viz. Computer Knowledge Test will commence immediately after completion of Section-II and will be for a duration of 15 minutes. On completion of Section-III, Session-I will come to an end.
- 13.8.7 After the completion of Session-I, the candidates will get a break for reregistration for Session-II.
- 13.8.8 Session-II will include conducting of Section-IV i.e. Skill Test/Typing Test.

13.8.9 It will be mandatory for the candidates to qualify all the sections of Tier-II.

- 13.8.10 Tier-II will consist of Objective Type/Multiple choice questions, except for Section-IV. The questions will be set in English, Hindi and any language opted by the candidate in the application form, as given at Annexure- XVI except for Part-A (i.e. English Language and Comprehension module) in Section-II.
- 13.8.11 There will be negative marking of 1 mark for each wrong answer in Section-I, Section-II and Section-III. Candidates are, therefore, advised to keep this in mind while answering the questions.
- 13.8.12 Section-III i.e. Computer Knowledge Test is mandatory but qualifying in nature.
- 13.8.13 Section-IV i.e. Skill Test/ Typing Test:
 - 13.8.13.1 Section-IV will include conducting of Skill Test/ Typing Test in Session-II on the same day.
 - 13.8.13.2 Skill Test/ Typing Test will be of qualifying nature.
 - 13.8.13.3 Skill Test/ Typing Test will be evaluated as per the evaluation guidelines available on the website of the Commission.
 - 13.8.13.4 Errors in the Skill Test will be calculated up to 2 decimal places.
 - 13.8.13.5 Skill Test/ Typing Test will be conducted as per the following scheme:

13.8.13.6 Skill Test for Data Entry Operator:

(i) Skill Test is mandatory for Data Entry Operators. No candidate is exempted from appearing in the Skill Test.

(ii) Part A - Skill Test for the post of DEO/ DEO Grade 'A' in Department/ Ministry mentioned at Para 8.1: The 'speed of 15000 (Fifteen Thousand) Key Depressions per hour on Computer' will be adjudged on the basis of the correct entry of words/ key depressions as per the given passage. The duration of the Test will be 15 (Fifteen) minutes and printed matter in English containing about 3700-4000 key-depressions would be given to each candidate who would enter the same in the Computer. The passage to be entered in the computer may also be displayed on the computer screen.

(iii) Part B - Skill Test for the post of DEO/ DEO Grade 'A' except in Department/ Ministry mentioned at Para 8.1: 'Data Entry Speed of 8,000 (Eight Thousand) Key Depressions per hour on Computer' will be adjudged on the basis of the correct entry of words/ key depressions as per the given passage. The duration of the Test will be 15 (Fifteen) minutes and printed matter in English containing about 2000-2200 key-depressions would be given to each candidate who would enter the same in the Computer. The passage to be entered in the Computer may also be displayed on the computer screen.

(iv) Candidates eligible for scribe as per **Para 7.1, 7.2 and 7.3** will be given compensatory time of 5 minutes. Therefore, duration of Skill Test for such candidates will be 20 minutes.

13.8.13.7 Part C - Typing Test for other posts i.e. LDC/ JSA:

(i) The medium of Typing Test will be Hindi or English. The candidates will have to opt for the medium of Typing Test (i.e. either Hindi or English) in the online Application Form.

(ii) The choice of Typing Test given by the candidate in the online Application Form shall be treated as final and no change in the medium of Typing Test will be entertained later.

(iii) Candidates opting for English medium should have typing speed of 35 words per minute (w.p.m.) and those opting for Hindi medium should have typing speed of 30 words per minute (w.p.m.). 35

w.p.m. and 30 w.p.m. correspond to about 10500 key depressions per hour and about 9000 key depressions per hour respectively.

(iv) The speed will be adjudged on the accuracy of typing on the Computer of a given text passage in 10 minutes.

(v) Candidates eligible for scribe as per **Para 7.1, 7.2 and 7.3** will be given compensatory time of 5 minutes. Therefore, duration of Typing Test for such candidates will be 15 minutes.

(vi) Passage Dictators will be provided to those VH candidates for the Typing test who have opted for scribe in the online Application Form. The Passage Dictator will read out the passage to VH candidate within the allotted time period.

(vii) Persons with Disabilities candidates who claim to be permanently unfit to take the Typing Test because of a physical disability may, with the prior approval of the Commission, be exempted from the requirement of appearing and qualifying at such test, provided such a candidate submits a Certificate in the prescribed format (**Annexure-XIV**) to the Commission from the competent Medical Authority, i.e., the Civil Surgeon of a Government Health Care Institution declaring him to be permanently unfit for the Typing Test because of a physical disability. In addition, such candidates must substantiate their claim by furnishing the relevant Medical Certificate in the prescribed format as per **Annexure-XI** to **Annexure-XIII** of the Notice of Examination, as applicable, at the time of Typing Test. Otherwise their claim for seeking exemption from Typing Test will not be entertained by the Commission.

14. Admission to the Examination:

Subsequently, qualified candidates will be issued Admission Certificates for the next stages of the Examination.
- 14.2 The Commission will not undertake detailed scrutiny of applications for the eligibility and other aspects at the time of written examination and, therefore, candidature will be accepted only provisionally. Candidates must go through the requirements of educational qualification, experience, age, physical and medical standards etc. and satisfy themselves that they are eligible for the post(s). The certificates/documents in support of their Educational Qualifications and Caste/Category, etc. shall be sought at Verification the time of Document bγ the Indenting User Ministries/Departments/Organizations.
