(6) **Age Limit** :-

Minimum 18 years and maximum 25 years as on **01.07.2025** i.e must have been born not earlier than **02.07.2000** and not later than **01.07.2007**. No age relaxation (upper age limit or lower age limit) shall be permissible.

- **7.3** After ensuring the correctness of the particulars in the application form, candidates are required to pay fees through the payment gateway on RRC-NWR, Jaipur website which has been integrated with the online application. - ii. After scrutiny of applications by Scrutiny Committee short-listed eligible candidates will be called for Document Verification & Trial of sports performance. Candidates who will be found suitable in Document Verification by Document Verification Committee, Trials of those candidates will be conducted by Trial Committee. Trial Committee will conduct trial to assess their sports performance and suitability for Railway/Unit team as well as Indian Railways team. Trial Committee shall give its recommendation in terms of either FIT or NOT FIT, for consideration for next stage, by giving marks as per the criteria given below:-

- **iii.** After Trial only the FIT Candidates in trial shall be considered for the next stage i.e. assessment of sports achievement & educational qualification by the Recruitment Committee.
- **iv.** Recruitment Committee shall award the marks (out of 60 marks) only to the FIT candidates for their sports achievements, educational qualifications etc. Candidates declared 'NOT FIT' will not be assessed further by the Recruitment Committee.
- v. Assessment of sports achievement & educational qualification of the FIT candidates shall invariably be held on the same day, just after trials or at the most, next day of the trials.
- **vi.** Recruitment Committee is to add the marks given by the Trial Committee to the FIT candidates (i.e., out of 40 marks), in order to make the final merit list (out of 100 marks.)

Note: The offer of appointment shall be given purely on the basis of merit. In case more than one sportsperson score the same marks, preference should be given to younger candidate to decide the merit.

(9) Important Instructions:-

- (i) Recruitments of sportspersons shall be dealt as per Railway Board's letter no. 2010/E (Sports)/4 (1)/1 (Policy) dated 31.12.2010 read with modifications/amendments issued by the Railway Board from time to time.
- (ii) Any subsequent changes in the terms and conditions of the Employment Notice as per extant rules will stand good. RRC reserves the right to consider/incorporate any subsequent changes/modification/additions/cancellation in the terms & conditions to recruitment under this Employment Notice as and when applicable.
- (iii) Applicant should possess requisite educational qualification and sports achievements before submitting the online application.
- (iv) In case any applicant has difficulty in filling their applications ONLINE, they are free to contact the help line numbers displayed on RRC website.
- (v) Merely filling up online application on RRC website or issue of call letters for trial to the candidate will not imply that his candidature has been finally cleared. Candidate's admission at all stages of the recruitment will be purely provisional subject to satisfying the prescribed eligibility conditions.

- (xiv) Sports person recruited against sports quota shall be terminated from service, if the information and documents furnished by him/her for recruitment are found incorrect/fake at any stage.
- (xv) Candidates must bring all documents uploaded with online application form & other requisite documents in Original along with one set of **self attested** photo copies on the day of trial, without which they will not be allowed to appear in the Trial. Certificates in languages other than English or Hindi should be accompanied by a self attested translation in English/Hindi. - b. Where the certificates are issued by Gazetted Officers of the Union Government or State Governments, they should be in the same form but countersigned by the District Magistrate or Dy. Commissioner (Certificate issued by Gazetted Officers and attested by District Magistrate/Deputy Commissioner are not sufficient)
- c. The OBC certificate from the authorities only will be accepted:-
 - District Magistrate/Additional District Magistrate/Collector/Deputy Commissioner/Additional Deputy 1 Commissioner/Dy. Collector/Ist Class Stipendiary Magistrate/Extra Assistant Commissioner (not below the rank of Ist Class Stipendiary Magistrate)/ * Sub-Divisional Magistrate/ Taluka Magistrate/Executive Magistrate.
 - Chief Presidency Magistrate/Additional Chief Presidency Magistrate/Presidency Magistrate.
 - 3 Revenue Officers not below the rank of Tehsildar.
 - Sub-Divisional Officers of the area where the candidate and/or his family normally resides.
 - 5 Certificates issued by Gazetted Officers of the Central or of a State Government Countersigned by the District Magistrate concerned.
 - Administrator/Secretary to Administrator (Laccadive, Minicoy and Admindivi Islands)
