As per the amendment made by the Government in the Haryana Finance Department (Group-B) Service Rules, 1980 vide notification dated 08.07.2025, the plan of examination has been amended as under:-

Note:-

- i) Paper –I shall be of multiple choice objective type OMR based for the selection of candidate for main examination (written) i.e. Paper II and Paper III.
- ii) Paper-III will be printed in both the Hindi and English language. Candidate shall be allowed to answer the question either in Hindi or English but not partly in Hindi and partly in English.
- The total number of candidates to be admitted to the main examination (written) shall be 15 times the number of advertised vacancies. Similarly, the total number of candidates to be called for viva voce shall be three times of the advertised vacancies.
- iv) No candidates shall be called for the viva-voce test unless he attains at least 40 % marks in the aggregate of all the written papers and a score of minimum 33 % marks in each written paper.
- v) Final merit list will be prepared keeping in view the total marks of Papar II, III and viva voce.

Besides above, after issuance of advertisement No. 23/2023, the Govt. has issued notification No. 22163/2024-5HR-III dated 13.11.2024 regarding sub-categorization of Scheduled Castes of Haryana. Accordingly, the distribution of posts has been revised as under –

Further, the Government of Haryana has revised the criteria of Creamy Layer for BCA & BCB categories candidates of Haryana. The latest Govt. instructions for BCA/BCB category are as per Government of Haryana Notification No. 22/132/2013-1GS-III dated 22.03.2022 and Government of Haryana Notification No. 40/13/2024-1SW dated 16.07.2024.

In view of the above mentioned facts, the Commission has decided to reinitiate the recruitment process by following the procedure as mentioned below –

1. Candidates who had applied earlier against Advt. No. 23/2023 with closing date 28.04.2023

Candidates who had already applied against Advt. No. 23/2023 with closing date 28.04.2023 are compulsorily required to register on the online portal https://hpsc.gov.in. After login, they will be shown their previous application details. Such candidates have to carefully note the points given below:—

- a. Candidates will be able to register on the portal by entering their registration number of the previously filled application form. OTP will be sent on the candidates' Email and Mobile for verification purposes. Once, the OTP is successfully authenticated, candidates can set their password for Login into the application by using their previous Registration Id and the password as updated by the candidate.
- b. After Logging in, Candidate will be shown their previously entered details. Basic details like Name, Gender, DOB, Father/Mother name will not be editable. However, candidate will be able to edit his/her category details.
- c. All such candidates have to MANDATORILY upload all the documents related to Age, Education and Category. Eligibility of such candidates shall be determined as per the cut-off date <u>DATE</u> of Advertisement 23/2023 which is 28.04.2023.
- d. BCA/BCB candidates will upload their category certificate in view of the Government of Haryana Notification dated 25.02.2019, 17.11.2021 & 22.03.2022 and issued during the period 01.04.2023 to 28.04.2023.
- e. SC candidates would have to MANDATORILY update their OSC/DSC status as per Government of Haryana notification No. 22163/2024-5HR-III dated 13.11.2024 and upload the corresponding valid certificate.

- f. EWS candidates will upload their category certificate in view of the instructions issued vide Government of Haryana notification No. 22/12/2019-1GSIII dated 25.02.2019 and MANDATORILY upload corresponding valid certificate. This certificate should be valid for the financial year 2023-24 & should be issued between 01.04.2023 and 28.04.2023. Certificates not issued within the above mentioned date ranges would not be considered.
- g. ESM/DESM/PwBD candidates will update their ESM/DESM/PwBD status and MANDATORILY upload corresponding valid certificates.
- h. All candidates will have to MANDATORILY upload their required Qualification documents. The eligibility of such candidates will be as per Advertisement 23/2023 with closing date i.e. 28.04.2023.
- All the candidates will have to MANDATORILY take the PRINT of the submitted details and upload a SELF SIGNED copy of the same, failing which their candidature will not be considered for further process.
- j. All such candidates will not have to make the payment and their previous payment will be considered.
- k. In case any candidate faces any problem with the earlier application, she/he shall fill a fresh application form.

2. Candidates who are applying afresh against the corrigendum dated 08.08.2025

All such candidates to carefully note the points given below:-

a. Candidates will have to register on the portal by entering their basic details like Name, Father Name, Mother Name, DOB, Email and Mobile Number. OTP will be sent on the candidates' Email and Mobile for verification purposes. Once, the OTP is successfully authenticated, a Registration ID will be issued and candidates can set their password for Login.



- b. After Logging in, Candidate will be able to fill up the online application form.
- c. BCA/BCB candidates must enter their category details as per instructions issued via Government of Haryana Notification No. 22/132/2013-1GS-III dated 22.03.2022 and Government of Haryana Notification No. 40/13/2024-1SW dated 16.07.2024 and upload the corresponding valid certificate issued between 01.04.2025 & 01.09.2025.

- d. SC candidates would have to MANDATORILY upload their OSC/DSC certificate as per Government of Haryana notification No. 22163/2024-5HR-III dated 13.11.2024.
- e. ESM/DESM/PwBD category candidate must provide all the required details in the online application form. All the candidates must ensure their eligibility in the respective category(ies) on the last date for submission of applications under this corrigendum which is 01.09.2025.
- f. All the candidates will have to MANDATORILY take the PRINT of the submitted details and upload a SELF SIGNED copy of the same, failing which their candidature will not be considered for further process.
- g. Such candidates will have to make the required payment as per details given below failing which their candidature will not be considered for further process:-

3. Important Notes:

- i. All candidates are advised to read the instructions mentioned in the advertisement No. 23/2023 carefully before submitting the online applications form. Further, incomplete and defective application form shall be summarily rejected.
- ii. The candidates, who have applied earlier against advertisement No. 23/2023, must update their application form and upload all the necessary documents including a scanned and signed copy of the submitted application form.
- iii. The candidates, who have applied earlier against advertisement No. 23/2023 their educational qualifications, age and other eligibility etc. will be determined on the last date for submission of online application form to the Commission i.e. 28.04.2023.
