**Sub-Inspector in Delhi Police and CAPFs Examination, 2024 –
Declaration of Result of Paper-II to call candidates for Medical Examination**

Result of Physical Endurance Test/ Physical Standard Test (PET/PST) of Sub- Inspector in Delhi Police and CAPFs Examination, 2024 was declared by the Commission on 03.02.2025, wherein 24190 candidates (Male- 22236 and Female- 1954) and 04 'Temporary Unfit' candidates were shortlisted for appearing in Paper-II. Paper-II of the said examination was conducted on 08.03.2025. Subsequently, Paper-II for additional 59 candidates was conducted on 30.04.2025.

2. As per the provisions of Para-16.2 of the Notice of Examination, only those candidates who scored more than the minimum qualifying marks (without adding bonus marks to NCC certificate holders) in Paper-II i.e. UR: 30% (60 marks), OBC/ EWS: 25% (50 marks) and all other categories: 20% (40 marks), have been considered for short-listing to appear in Medical Examination.

3. As per the provisions of Para-12.5 of the Notice of Examination, NCC certificate holders have been given bonus marks provisionally in Paper-I and Paper-II for processing the result.

4. All the candidates who have secured the minimum qualifying marks in Paper II as mentioned in Para-2 above, have been considered for shortlisting to appear in Medical Examination. Accordingly, total of 22,269 candidates (Female-1889 as per List I and Male-20380 as per List II) have been shortlisted.

5. Schedule of Medical Examination will be intimated to the candidates in due course. Candidates are advised to follow the websites of the Commission regarding issue of Admission Certificate for Medical Examination.

6. The result in respect of 76 candidates have been kept withheld due to various reasons. Roll No of these candidates is as per List-3. Medical Examination in r/o these withheld candidates will be conducted provisionally.

7. 25 candidates, as per List-4, who were provisionally allowed to appear in Paper-II based

on various Court orders, though they had not successfully qualified/ remained absent in either of the earlier stages of the examination process. These candidates have not been recommended for Medical Examination. However, the same is subject to the final outcome of respective ongoing Court cases viz. WP No 3512/2025 (Hon'ble High Court of Delhi), WP No. 38892/2024 (Hon'ble High Court of Kerala), WP No. 3469/2024 (Hon'ble High Court of Indore) and other related cases.

8. 21 candidates have been debarred i.r.o. SI-CPO Exam, 2024 due to malpractices, details are as follows –
