(a) Method of recruitment:

By selection (direct recruitment) through West Bengal Health Recruitment Board;

(b) Qualifications:

Passed H.S. (10+2) Examination or its equivalent with Physics, Chemistry, Biology and a two year Diploma course in Medical Technology in the concerned subject recognized by the State Medical Faculty of West Bengal under West Bengal Para Medical Council or conducted by any recognized Institution affiliated to any recognized University; **OR**, a Bachelor Degree in Medical Technology of the subject concerned from any Institution / University recognized by Government of West Bengal;

E- Age:

Not less than 21 years and not more than 39 years as on the 1st January of the year in which advertisement is published.

Provided that the provisions of the West Bengal Services (Raising of Age limit) Rules, 1981 shall apply as long as the same remain in force.

Provided further that age may be relaxed for the candidates belonging to the categories of Scheduled Castes, Scheduled Tribes and Other Backward Classes as per Government rules or orders issued from time to time.

Note:

1) Passed H.S. (10+2) Examination or its equivalent with Physics, Chemistry, Biology:

A. Candidates are requested to upload Mark Sheet(s) including supplementary mark sheets, if any along with passed certificate of H.S. (10+2) Examination or its equivalent with Physics, Chemistry and Biology in the space provided for the same.

B. Candidates are requested to generate a single PDF containing Mark Sheet(s) including supplementary mark sheets, if any along with passed certificate of H.S. (10+2) Examination or its equivalent with Physics, Chemistry and Biology and then upload the documents in the “Upload Marksheet” space provided for the same.

C, Marks obtained in Physics, Chemistry and Biology will be considered for calculation of percentage of marks for Higher Secondary or equivalent examination. K- Instruction to the candidate:

- **DEPARTMENTAL CANDIDATES ARE ELIGIBLE FOR THE POST. However, those who are in regular service in the same post, should not apply.**
- The Board may decide to hold Written Examination or Computer Based Test (CBT), at any subsequent stages of the recruitment process, for either shortlisting of candidates for interview, or for preparation of Overall Performance List. Accordingly, the marks distribution pattern, mentioned in clause 'H' of this advertisement, may be changed, if such Written Examination or Computer Based Test (CBT) is conducted for recruitment to the above mentioned post.
