**Sub : Releasing of marks of Tier-I examination and shortlisting of candidates for Skill Test in respect of Post Code 802/23 under combined examination scheme.**

1. The DSSSB vide its advertisement no 05/23 read with corrigendum No. 5919-31 dated 05.09.2024 and 137074/2026 dated 16.02.2026 has revised the total number of vacancies as 3050 including PwBD 177 (Sub category a-50, b-65, c-34, d&e-28), ExSM-344, SP-132 (UR-1356,EWS-284, OBC-810, SC -430, ST-170) for post Code 802/23 under the Combined Examination Scheme in different Departments.
2. The written examination (online mode) was conducted on 01,04, 05, 08 to 11, 13 to 17, 21,22,27,29 & 30.10.2025
3. The marks obtained by **72609 candidates** who have duly appeared in examination (online mode) have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on **www.dsssbonline.nic.in**.
4. Based on the performance in the Tier-I examination (online Mode), a total of **25385 candidates** who obtained marks above or equal to cut-off marks in their respective categories, as detailed below, have been provisionally shortlisted to appear in Skill Test, subject to the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Skill Test separately.



Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing in Skill Test does not entitle them any right over the post.
6. Only those candidates have been considered in OBC Category who has declared that they have obtained OBC (Delhi) cast certificate in their online Application.
7. Reserved Category candidates who obtained marks above or equal to the last shortlisted UR category candidates in Tier-I have only been shortlisted against UR vacancies for skill test or otherwise they are shortlisted in their respective category.
9. As per the Advertisement the minimum qualifying marks in one Tier examination for :-
 

UR & EWS	: 40%
OBC (Delhi)	: 35%
SC, ST & PwBD	: 30%

 Ex-servicemen will be given 5% relaxation in their respective categories subject to a minimum of 30%
10. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and there fore mere inclusion of names in the list of candidates qualifying for appearing in Skill Test does not entitled them any right over the post.
11. **The details of Skill Test shall be notified separately by the Board. The candidates are advised to check the Board's website regularly.**
12. The above short-listing for Skill Test for the Post Code- 802/23 under combined examination scheme will be subject to outcome of pending court cases OA. No 634/2024 & 4122/2025 and other court cases, if any.
13. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
