With reference to the above, it is hereby informed that, the **Screening Test** for the post of “**Peon/Hamal/Farash**” on the establishment of the High Court of Judicature at Bombay, Principal Seat at Bombay and it’s Benches at Nagpur and Aurangabad, is scheduled on **Sunday, 26<sup>th</sup> April, 2026** in two Batches (i.e. Batch – I & Batch – II) district-wise at Mumbai, Ahmednagar, Akola, Amravati, Beed, Bhandara, Buldana, Chandrapur, Aurangabad (Chhatrapati Sambhajinagar), Osmanabad/Dharashiv, Dhule, Gadchiroli, Gondia, Hingoli, Jalgaon, Jalna, Kolhapur, Latur, Nagpur, Nanded, Nandurbar, Nashik, Thane, Parbhani, Pune, Raigad-Alibag, Ratnagiri, Sangli, Satara, Sindhudurg-Oras, Solapur, Wardha, Washim and Yavatmal.

Examination Centres have been allotted to all candidates based on the postal address provided in their application form. Those candidates who have mentioned Dadra and Nagar Haveli at Silvasa, Diu & Daman, North-Goa/Panaji, Other and South-Goa in their application forms have been allotted centres in Mumbai District. Those candidates who have mentioned Palghar in their application forms have been allotted centres in Thane District.

**No request for change of Examination Centre will be considered or entertained.**

The candidates are requested to remain present for Screening Test for the post of “Peon/Hamal/Farash” at the Examination Centres mentioned against their respective names **at Column No. 8.**

The candidates are directed to report at the reporting time mentioned against their respective names **at Column No. 6** and to remain present for Screening Test at their own expenses.

The candidates can download their Hall Ticket/Admit Card in respect of above test from the official website of Bombay High Court, i.e. <https://bombayhighcourt.nic.in> from **21/04/2026 from 11.00 a.m. onwards** and should bring the same at the time of Screening Test.

For the purpose of identification, the candidates are required to bring their any one original photo identity proof viz. Aadhar Card or Election Card or PAN Card or Driving Licence or Passport etc. In case of change of name, the candidates are required to bring Gazette/Marriage certificate etc. or any other relevant document in support thereof alongwith Hall Ticket/Admit Card.
