Information regarding the city of examination and Admission Certificate for the candidates of Combined Hindi Translator Examination, 2026(Tier-I) and Stenographer Grade 'C' &'D' Examination, 2026 (Tier-I).

As per Notice published by the Commission, Combined Hindi Translator Examination, 2026 (Tier-I) is scheduled to be held on 08.09.2026 and Stenographer Grade 'C' &'D' Examination, 2026 (Tier-I) is scheduled to be held from 09.09.2026 to 12.09.2026. The candidates of Tier-I of Combined Hindi Translator Examination, 2026 and Stenographer Grade 'C' &'D' Examination, 2026 can view their examination city details by logging in through the designated login module on the website of the Commission (<https://ssc.gov.in/>).

2. The 'Admission Certificate' for the said examinations will tentatively be available for download prior to two/three (02/03) days of respective examination date. The same can be accessed through the designated login module on the website of the commission in a similar manner. Detailed instructions in this regard are available in the Notice published on 23.04.2026 and 24.04.2026 respectively on the website of the Commission.

3. The candidates availing the 'Own Scribe' facility in Combined Hindi Translator Examination, 2026 (Tier-I) and Stenographer Grade 'C' &'D' Examination, 2026 (Tier-I), may require to do fresh Scribe registration on the Commission's website, as the registration of scribes prior to 05.11.2025 were disposed off.

4. The Scribe registration has now been integrated with the Aadhaar Authentication. Therefore, it is mandatory that all such personnel, willing to enrol/ appear as a scribe, may complete their fresh registration on the Commission's website.

5. Candidates who are willing to avail the 'Own Scribe' facility in any of these examinations will be required to submit their Scribe's registration number for generation of their Scribe's Entry Pass. It has been decided by the Commission that the maximum permissible age limit of personnel appearing as own Scribe will be as per the updated policy No. PP001/14/2024-PP (e-10280) dated 04.11.2025. Rest of the guidelines regarding the Scribe facility will remain same as per the notice of the respective examination.

6. Candidates who have opted for 'own scribe' will be able to map their Scribe OTR till 06.09.2026 (11:00 P.M.) for Combined Hindi Translator Examination, 2026 (Tier-I) and till 07.09.2026 (11:00 P.M.) for Stenographer Grade 'C' &'D' Examination, 2026 (Tier-I). **Scribe Entry Pass will be generated only for those candidates who successfully map their Scribe OTR.**
