Application of such candidates submitted without '**No objection Certificate**' shall not be accepted by the Recruitment Board.

(vi) The selected candidates should submit a bond to serve for a minimum period of three years with the Force **or** for a specific period as prescribed from time to time. The concerned Sports personnel shall give an undertaking through a Bond of the sum of **Rs.1,00,000/-** that he/she would serve the Force for **at least 3 years** to promote sports in the Force before tendering his/her resignation for better employment elsewhere or on any other ground. The above bond may be obtained in the enclosed proforma (**Annexure-“B”**) and kept on record by his/her respective Group Centre/Unit under intimation to Central Sports Officer at Dte.

5. UPPER AGE RELAXATION: -

- i) Age 18 to 23 years. Candidate should not have been born earlier than 02/01/2003 and later than 01/01/2008. Cut-off date for determining age will be **01/08/2026**. Relaxation will be given to candidates of various categories as under:

- ii) Crucial date for claiming SC/ST/OBC/EWS status will be the closing date for receipt of applications. A person seeking appointment on the basis of reservation to OBCs must ensure that he/she possesses the caste/community certificate and does not fall in creamy layer on the crucial date.
- iii) Candidates who wish to seek age relaxation must submit requisite certificate from the competent authority, in the prescribed format when such certificate are sought by the Recruitment Board. Otherwise, their claim for SC/ST/OBC(NCL) status will not be entertained and their candidature/applications will be considered under General (UR) category.
- iv) The formats of the above certificates are annexed as **Annexure-“E” to Annexure-“I”**. Certificate obtained in any other format will not be accepted.
- v) Upper age limit is relaxable up to 5 years for Departmental candidates with three years continuous service and in addition 5 years age relaxation for Scheduled Caste or Scheduled Tribe and 3 years for Other Backward Classes (NCL) who compete along with candidates for open recruitment.

6. MARKING ACHIEVEMENTS/TRIAL TEST: -

- (i) Only those players who have represented or won medal (s) in the levels of competition mentioned in **Para-4**, two years prior to date of publication of this Advertisement **i.e. 30/09/2026**, are eligible to apply.
- (ii) Candidate will be given marks for any one highest medal secured by him/her during the period mentioned at 6(i) above. If any candidate has secured more than 01 medal in a particular competition, in that case he/she shall be awarded marks for only

the highest medal/Position secured in the competition and marks given for separate competitions shall not be included in overall sports achievements.

- (iv) The Board of Officers detailed for conducting recruitment of HC/GD and CT/GD against Sports quota may also recommend cases of Outstanding Sportspersons of those games who produces Certificates for winning excellence in International or National Sports arena, shows excellent performance during Sports Trial Test and he/she also has the potential of winning laurels for CRPF as well as for Country in various AIPG, National and International Sports Competitions, but requires some relaxation in Height, chest and weight due to requirement of their particulars Sports by clearly mentioning/pointing out the desired relaxation. Their case can also be considered for recruitment against Sports quota **subject to approval by the Ministry of Home Affairs only**. While considering cases for recruitment, the Board of Officers shall examine and submit the trial report of candidates in the format given in **Annexure "C"**.

(v) ORDER OF PREFERENCE:

a)	First Preference to those candidates who have represented the country in an International Competition with the clearance of the Department of Sports, Ministry of Youth Affairs and Sports.
b)	Next preference may be given to those who have represented a State/U.T. in the Senior or Junior level national Championships organized by the National Sports Federations recognized by Department of Sports, Ministry of Youth Affairs & Sports or National Games organized by Indian Olympics Association and have won medals or positions up to 3rd place. Between the candidates participating in Senior and Junior National Championships/games, the candidates having participated and won medal in Senior National Championship should be given preference
c)	Next preference may be given to those, who have represented a University in an Inter-University competition conducted by Association of Indian Universities/Inter University Sports Board Or Khelo India University Games conducted with authorization of Department of Sports, Ministry of Youth Affairs and Sports and have won medals or positions up to 3rd place in finals.
d)	Next preference may be given to those who have represented a State/UT in Khelo India Youth Games (age category above 18 years) or Khelo India Winter Games conducted with authorization of Department of Sports, Ministry of Youth Affairs and Sports and have won medals or positions up to 3rd place in finals.
e)	Next preference may be given to those who have represented the State Schools in the National sports/games for Schools conducted by the All-India School Games Federation and have won medals or positions upto 3rd place.
f)	Next preference may be given to those who represented a State/Union Territory/University/State Schools Teams at the level mentioned in categories (b) to (e) but could not win a medal or position, in the same order of preference.

Note 1: In the event of tie, candidate who has secured a higher position or won more than one medal may be given preference.

Note 2: Participation in individual event and team event may be given the same preference.

Note 3: No preference may be given for winning more than one medal/position. (Except condition mentioned at Note 1)

Note 4: In case of any doubt about the status of a tournament, the matter will be decided by the Department of Personnel & Training in consultation with Department of Sports, Ministry of Youth Affairs and Sports.

Note-1: Relaxation in height and chest (as the case may be) as mentioned above will be permissible **only on production of certificate at the time of PST** in the proforma as prescribed in **Annexure- “I”** from the competent authorities.

Note-2: Those candidates who are declared not qualified in Physical Standards Test, i.e., height and chest may prefer an appeal on same day, if they so desire, to the **appellate authority** nominated through **Chairman of the Board**. - (i) **Eye Sight** -The minimum distance vision shall be 6/6 and 6/9 for both eyes without correction i.e. without wearing spectacles or lenses;
- (ii) A colour blind person shall not be eligible for recruitment. If a person is found to be colour blind at any stage of service career, he/she shall be boarded out as per Medical SHAPE policy in vogue;
- (iii) The candidate must not have knock knee, flat foot, varicose veins or squint in eyes.
- (iv) Must be in good mental and bodily health and free from any medical condition or physical defect likely to interfere with the efficient performance of duties or a cause of rejection as per the revised Medical Guidelines for CRPFs and AR issued vide MHA U.O. - (v) **Tattoo**: -
 - (a) **Content**: Being a secular country, the religious sentiments of our countrymen are to be respected and thus, tattoos depicting religious symbol or figures and the name, as followed in Indian Army are to be permitted.
 - (b) **Location**: Tattoos marked on traditional sites of the body like inner aspect of forearm but only left forearm, being non-saluting limb or dorsum of the hands are to be allowed.
 - (c) **Size**: Size must be less than $\frac{1}{4}$ of the particular part (Elbow or Hand) of the body.

Note-1: A declaration is to be given by the candidates in a format which will be provided to candidates at the time of Medical Examination regarding history or presence of diseases and treatment taken, if any, evidence of which is not readily obtainable during the medical examination. - (l) Detailed Medical Examination (DME) :-** Candidates selected in order of merit as per number of vacancies will be put through detailed medical examination to assess their fitness as per the medical guidelines issued from time to time by MHA. **(Annexure-'O')**

(m) Review Medical Examination (RME) :-
